4 Open session

4.1 Public participation:

- a) Mr Dave Shepherd said that he is anxious to know when the speed checks will recommence, as the volume of traffic is increasing along Ufton Fields. Cllr Burrows will call Sally Rolfe to ask when the speed gun will be returned.
- b) Mr Greg Byrne explained about his recent planning application. This is to enable him to become an approved firewood seller. The purpose is to keep the wood dry. Cllr Crowther asked for assurance that the noise of the machinery would not disturb people walks in this area and Mr Byrne confirmed that the machinery will be running for a maximum of 4 hours per day but not every day. Mr Byrne also suggested he could provide some form of screening to reduce noise levels on the footpath.
