4 Open session

4.1 Public participation:

a) Mr Shepherd advised that the light opposite St Michael's Close is not working

b) Mr Shepherd also asked about the speed gun and when it would be available again.

4.2.1 District Councillor Chris Spencer reported:

a) There will be a review of Polling Station arrangements in Stratford District Council's area. Ufton's arrangements will remain the same.

b) The Community Links Bus has had its budget cut and it will be looking to Parish Council's to help finance this.

c) The expenditure for the Chair of Stratford District Council has been cut by $\pounds 2,000$ to $\pounds 8,000$ per annum.

4.2. County Councillor Bob Stevens reported:

a) The Library Consultation is now complete. 16 libraries were earmarked for closure. 5 will be shut and the others will be run by the Local Community with a kick-start capital grant. Harbury will be among the latter group.

b) Youth Clubs will be community run. Southam's Youth Club will remain in the Graham Adams Centre.

c) The Police Bill is going through Parliament and if it is passed, the Police Commissioner will be elected.

d) The Health Bill is going through the Lords

e) Parliamentary Boundaries will be changed. Ufton will remain in Stratford but Parliamentary-wise may be in Rugby with effect April 2013.

meeting were confirmed as a true record and signed by the Chairman. Proposed Cllr Crowther, seconded Cllr van Kesteren.

Cllr Burrows proposed and Cllr Baldwin seconded that the Parish Council gives an additional $\pounds 500$ this year to cover the total cost of moving. This would be a one-off payment with a proviso that it will be

reviewed next year when the Precept is calculated. Cllr Crowther abstained but all others present agreed to this proposal. Cllr Crowther then thanked the Parish Council on behalf of the Church.
