It was proposed by Cllr Baldwin, seconded by Cllr Mrs Kemp and **RESOLVED** the payments be made.

10.3 Precept 2020 – 2021

There followed a long discussion about the precept for 2020 – 2021. Cllr Baldwin also requested item 11 be discussed as this point. Ufton Village Hall is finding it difficult to meet all its commitments and put aside money for maintenance and improvements. Cllr Baldwin would like the Parish Council to consider awarding the village hall a maintenance grant of approx. £2000 each year over the next 2 - 3 years.

The Parish Clerk advised the Parish Council the only mechanism the Parish Council has for making payments along this line is via a Section 137 payment. The maximum amount of money which can be awarded via this method for the financial year 2019 - 2020 is £1615.88 (199 registered voters x £8.12 per voter). This rises to £1655.68 for 2020 - 2021. The Parish Council has no authority to pay over and above this amount. The Clerk advised the Parish Council to ensure they stay within these limits.

The Parish Councillors asked for more information from the Clerk regarding the precept over the previous five years and the decisions made at the last two precept setting meetings.

The setting of the Precept for 2020 – 2021 was deferred to the next meeting.

It was proposed by ClIr Tayler, seconded by ClIr Crowther and **RESOLVED** the Parish Council is sympathetic to help the village hall with it's predicted expenses and will decide as part of the Parish Councils precept discussion and decision at the meeting due to be held on 7th January 2020.

11. HS2

HS2 have strimmed the top of the church wall, they have not strimmed the bank.
