A resident who is considering submitting a planning application has been advised it would be beneficial to have a Housing Needs Survey done for the village. The resident is prepared to pay for this and asked if the Parish Council will support the survey. The Parish Council indicated they would not be averse to a formal request, and it was agreed to discuss such a request at the next Parish Council meeting.

### **SDC Representatives Reports**

Cllr Adam will be raising the issue of dust being created by HS2 landing on roads and road furniture; many road signs are becoming ineligible. Cllr Adam will raise this with HS2 and Environmental Health. Sustrans, who are working on the old railway line in Long Itchington are due to give a presentation to Long Itchington Parish Council via Zoom on 28<sup>th</sup> February 2022. Cllr Adam will see if Ufton PC can be invited to attend the zoom meeting to. The merger between Stratford District Council and Warwick District Council is on-going.
