Warwickshire County Cllr

Cllr Kettle advised the traffic light installation at the Harbury crossroads will start in the new year. The permanent traffic lights will be "intelligent" and will react according to vehicular activity. The lights will always be on red to slow traffic down; they will change as drivers' approach. WCC will be undertaking more road works, there will be more road closures with diversions. HS2 Dorothy has started on the second tunnel. Cllr Kettle attended a site visit and travelled along the haul road from Southam to the Oxford canal by Fenny Compton. HS2 will try to use the haul road where possible as opposed to using the roads. A case of Avian Flu has been recorded in Napton, there is a 3km radius shutdown zone. WCC is looking to plant 20,000 acorns over Warwickshire during 2023.

Stratford District Cllr

Cllr Adam advised the Boundary Commission changes have been settled. As from May 2023 Ufton Parish Council will become part of the Harbury Ward. The Government are looking to introduce Voter ID at the May 2023 elections. SDC have written to the Government to ask for polling cards to be taken as ID. SDC have put £50,000 into "Act on Energy" for those people in financial need. Applications for this grant are now open and can be made in person, on someone else's behalf or by phone.
