**Stratford District Cllr Ostrander –** SDC has 39 wards and 41 Cllrs, there was a 42% turn out at the elections and only 12 people were turned away for not having appropriate ID to be able to vote. The Liberal Democrats are now the largest party within Stratford District Council, they have therefore taken control of the Council and formed a new council with portfolio holders which mirror the officer structure in SDC. Sub committees are chaired by Liberal Democrat Councillors, the Scrutiny Panel is chaired by the Conservatives as they are the second largest party. SDC are obliged to build 868 houses per year in this area. The Liberal Democrat Party will be concentrating more on enforcement that has been done previously. 20:50 hrs Cllr Kettle joined the meeting.
